WHAT'S INCLUDED

Rexpin Lane is committed to providing you, our valued client, with a healthy correctly bred Miniature Pinscher puppy.

All of our puppies are sold with a complete personal health record, up-to-date vaccinations, deworming, tail and dew claws removed at 3 to 5 days old and a one (1) year warranty against fatal hereditary diseases and fatal congenital malformations. All of our puppies are also properly socialized in a family environment. We strive to be the best and promise you our help and support after the sale of each and every puppy.

PROVISIONS FOR OUR HEALTH WARRANTY

Your Rexpin Lane puppy must be health certified, by you, within 72 hours of transfer of ownership. A signed copy of a health certificate must be provided to Rexpin Lane within five (5) days of sale date.

Your Rexpin Lane Miniature Pinscher puppy is sold with a one (1) year warranty against fatal hereditary diseases and fatal congenital malformations. If your puppy should encounter any such fatal disease or fatal malformations, that would result in permanent paralysis or death, you MUST forward a signed letter and explanation from a licensed veterinarian to Rexpin Lane and/or it's proprietors stating the condition or conditions of your puppy as well as the possible outcome of the existing health issues within five (5) days of the diagnosis.

It is the responsibility of the purchaser to provide immediate medical care and attention by a licensed veterinarian in the case of illness or distress. Your puppy MUST also receive all age appropriate vaccinations and health care in order for any and all warranties to be in effect.

In the event of a fatality, and once all of the content above has been provided to Rexpin Lane, along with all the AKC registration papers, a signed certificate stating that your puppy was spayed/neutered and all health records are returned, Rexpin Lane will then give you one (1) of the following options:

1. Replace your Miniature Pinscher puppy with one (1) from the next available litter,
2. refund one half of the original purchase price (shipping expenses are not part of the original purchase price and will therefore not be refunded),
3. pay one half of the veterinarian bills, not to exceed one half of the original purchase price.

The Rexpin Lane warranty expires when your puppy reaches his/her first birthday.

SPAY/NEUTER CONTRACT

If you have purchased your Miniature Pinscher puppy as a pet with a spay/neuter contract as stated in the SALES CONTRACT, then you MUST have your Rexpin Lane puppy spayed or neutered at the age of six (6) months. The purchaser MUST then provide a signed veterinarian certificate within five (5) days after the alteration of your puppy. All AKC registration papers will be held by Rexpin Lane until proof of alteration is given by the purchaser to Rexpin Lane. If you neglect or refuse to have your puppy surgically altered then all warranties become null and void.

Rexpin Lane Kennel reserves the right to take legal action against the purchaser in the event of a breach of this contract. All resulting legal fees encountered by Rexpin Lane Kennel and/or its proprietors will be the sole responsibility of the purchaser.

Rexpin Lane Kennel and the purchaser enter into this legally binding contractual agreement for the health and well being of the Miniature Pinscher puppy described in the SALES CONTRACT.
